The following requests totaling \$8,169,624 were made by Senator Manchin on behalf of West Virginia constituents and funded outside of the Fiscal Year 2023 Appropriations process:

Arthurdale Heritage Training Center (\$35,580): Funded through the Appalachian Regional Commission, this project provides funding to conduct a comprehensive survey historic preservation training opportunities and develop an operating plan for the proposed training center.

Minnie Hamilton Health Care Center (\$2,500,000): Funded through the Appalachian Regional Commission, this project provides funding for the first phase of the hospital's sewer renovation project, which will improve service for 10,540 patients annually by replacing existing lines under the facility with a sanitary sewer loop.

Oak Hill Collection System Rehabilitation (\$1,250,000): Funded through the Appalachian Regional Commission, this project makes critical repairs to over 9,150 linear feet of sewer line, reducing high amounts of inflow and infiltration (I&I) and improving service to 3,831 residential customers and 217 commercial customers within the Oak Hill sewer system.

Semper Liberi Recovery Integrated Supportive Employment (RISE) Program (\$484,044): Funded through the Appalachian Regional Commission, this project provides funding for the Semper Liberi Job Training Facility to provide comprehensive services to more than 175 trainees for job placement following recovery from substance abuse.

Wyoming County Barkers Creek Industrial Park (\$3,900,000): Funded through the Economic Development Administration, this project constructs three pre-engineered metal buildings to the Barkers Creek Industrial Park in Pineville, WV to create useable space for an environmentally friendly manufacturer of carbon products used in finished products such as electric vehicle batteries, radar absorbing military aircrafts, high quality asphalt binder for road and bridges.
