## **Senator Manchin's Efforts to Address Homelessness**

**February 5, 2019:** Senator Manchin announced two funding allocations from the U.S. Department of Labor (DOL), each in excess of \$1 million to help at-risk youth finish high school or other equivalency programs in West Virginia. The funds will also go to workforce training programs and be used to help build housing for homeless youth and their families.

**April 11, 2019:** Senators Manchin and Capito announced \$13,523,370 for 30 public housing authorities throughout the state of West Virginia from the U.S. Department of Housing and Urban Development (HUD). The funding from HUD's Public Housing Capital Fund will help West Virginia public housing authorities develop, finance and modernize their facilities as well as their management operations.

**August 12, 2019:** Senators Manchin and Capito announced \$7 million to support homeless veterans under the U.S. Department of Veterans Affairs' (VA) Supportive Services for Veteran Families (SSVF) Program.

September 17, 2019: Senator Manchin spoke with U.S. Department of Education (DOE) Secretary Betsy DeVos about the large increase in student homelessness in West Virginia. During the call, Senator Manchin and Secretary DeVos discussed innovative ways to address student homelessness. Manchin also outlined concerning statistics regarding child homelessness increases in West Virginia in the past year and asked her to come to West Virginia to see firsthand how it's impacting West Virginia children.

**September 19, 2019:** Senator Manchin included significant funding for West Virginia in the fiscal year (FY) 2020 Transportation and Housing and Urban Development (THUD); Agriculture, Rural Development, and FDA; and Financial Services and General Government (FSGG) appropriations bills.

- \$2 billion for programs such as the Rural Housing Stability Assistance Program to support fighting homelessness.
- \$80 million specifically for combatting youth homelessness.
- The bill also directed HUD to incorporate more federal data on youth homelessness into its annual assessment report and implementation of continuum of care programs.

October 4, 2019: Senator Manchin spoke at the Emergency Shelter Providers Network Conference in Roanoke, West Virginia to discuss youth homelessness.

October 9, 2019: Senator Manchin wrote about youth homelessness and the responsibility we have to immediately address this issue in our state.

**October 22, 2019:** Senators Manchin and Capito announced \$3,363,003 from the U.S. Department of Health and Human Services (HHS) to combat children and youth homelessness and help families affected by the opioid crisis in West Virginia.

October 31, 2019: Senator Manchin secured funding to combat youth homelessness in the minibus spending package that was passed by the Senate.

• \$2 billion for programs to stop homelessness, including \$80 million specifically to stop youth homelessness and language directing HUD to assist homeless children with school enrollment and other critical services.

**November 15, 2019:** Senators Manchin and Collins introduced, and unanimously passed a resolution to recognize November as National Homeless Children and Youth Awareness Month.

**December 19, 2019:** Senator Manchin secured \$181.5 million to combat youth homelessness in the FY20 appropriations package.

- \$80 million specifically to stop youth homelessness through HUD.
- \$101.5 million through McKinney-Vento grants through DOE.

**January 10, 2020:** Senators Manchin and Capito announced \$8,601,585 from HUD for multiple entities fighting against homelessness in West Virginia.

**February 21, 2020:** Senators Manchin and Capito announced \$47,559,125 from HUD for various housing development programs across West Virginia, which will help provide permanent housing options for those experiencing homelessness.

March 5, 2020: Senator Manchin questioned ED Secretary Betsy DeVos on the Administration's proposal for a \$4.7 billion cut to education programs, eliminating essential support for our education programs like those supporting homeless children and youth. Among the education programs included was McKinney-Vento Homeless Assistance Act funding which provides resources for schools to assist homeless children and youth in their classrooms.

**March 25, 2020:** Senator Manchin secured \$13.5 billion the *Coronavirus Aid, Relief, and Economic Security Act* (CARES) for youth homelessness.

- \$13 billion has been set aside for schools serving K-12 students that will be issued to States based on their Title I formula. McKinney-Vento is an allowable use of those funds, but it will be up to the State Department of Education to make that determination.
- \$25 million was set aside for this program to go to existing grantees. This will directly benefit the Children's Home Society in Charleston and Youth Services System in Wheeling in their work to provide services to homeless children and youth.
- \$425 million for Substance Abuse and Mental Health Services Administration (SAMHSA) to increase access to mental health services in our communities through Community Behavioral Health Clinics, suicide prevention programs, and emergency response spending that can target support where it is most needed, such as outreach to those experiencing homelessness.

**April 2, 2020:** Senators Manchin and Capito secured \$19 million for West Virginia for the Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) programs in the *CARES Act*.

 The CDBG program is a flexible program that provides communities and states with funding to provide a wide range of resources to address COVID-19, such as services for senior citizens, the homeless, and public services.

- The ESG program addresses the impact of COVID-19 among individuals and families who are homeless or at risk of homelessness, and supports additional homeless assistance, prevention, and eviction prevention assistance.
- **April 17, 2020:** Senators Manchin and Capito announced \$400,000 from HHS for Westbrook Health Services to address children and youth homelessness and help families affected by the opioid epidemic in West Virginia.
- May 7, 2020: Senator Manchin sent a letter to his Congressional colleagues urging them to invest in programs that provide critical services to children and youth experiencing homelessness in the next COVID-19 relief package.
- May 18, 2020: Senator Manchin led 40 bipartisan Senators in pressing Congressional leadership to include significant funding for the Federal TRIO Programs (TRIO) which are integral to supporting vulnerable students and their families that have been impacted by the COVID-19 pandemic, in future COVID-19 relief packages.
- May 19, 2020: Senators Manchin, Murkowski, Sullivan, and Sinema advocated for the Senate to provide support for children, youth, and families in crisis or experiencing homelessness during the COVID-19 pandemic. The bipartisan group of Senators asked for dedicated funding to be included in future COVID-19 relief packages in order to meet the unique and complex needs of homeless youth and families through the programs and systems that are best positioned to help them immediately.
- May 27, 2020: Senator Manchin led a bipartisan group of Senators calling on HUD Secretary Ben Carson to take action and work quickly to allocate all remaining CDBG and ESG funding from the *CARES Act* and publish comprehensive guidance for use of those funds, including for previously announced funding.
- **June 9, 2020:** Senator Manchin, along with a group of bipartisan Senators, introduced *S. 3923 the Emergency Family Stabilization Act* that would establish a \$800 million fund to assist families with children and youth currently experiencing or at-risk of experiencing homelessness.
- **July 21, 2020:** Senator Manchin calls on Congress to pass his bipartisan *Emergency Family Stabilization Act* after the West Virginia Department of Education announces that more than 10,300 students experienced homelessness during the 2019-2020.
- **August 5, 2020:** Senators Manchin and Capito announced \$3,778,006 for housing authorities across West Virginia through the Department of Housing and Urban Development's Housing Choice Voucher.
- **August 10, 2020:** Senators Manchin and Capito announced \$7,262,424 for non-profits organizations in West Virginia to assist combat veterans that are experiencing homelessness.
- **September 15, 2020:** Senators Manchin and Murkowski led a letter to the Administration for Children and Families at the U.S. Department of Health and Human Services requesting information on how COVID-19 has impacted homeless families, children, and youth.

**September 16, 2020:** Senators Manchin and Capito secured \$452,459 through the U.S. Department of Housing and Urban Development Housing Choice Voucher program for the Charleston/Kanawha Housing Authority.

**September 17, 2020:** Senators Manchin and Capito secured \$185,185 from the U.S. Department of Agriculture's Housing Preservation Grant program for three locations in West Virginia.

**October 5, 2020:** Senator Manchin issues a press release highlighting the need for dedicated funding for children and youth experiencing homelessness, which is why he introduced the *Emergency Family Stabilization Act*.

**October 23, 2020:** Senator Manchin highlights a report released by Chapin Hall at the University of Chicago that highlights the needs of children and youth experiencing homelessness in rural areas. This report highlights the need for Senator Manchin's *Emergency Family Stabilization Act*.

**November 20, 2020:** Senators Manchin and Collins led 19 bipartisan Senators in introducing a resolution to designate November 2020 as "National Homeless Children and Youth Awareness Month". This resolution honors and applauds the volunteers, businesses, governments, educators, and organizations working to assist children and youth experiencing homelessness.

<u>December 21, 2020</u>: Senator Manchin highlighted \$303.3 million included in the year-end spending package to address children and youth homelessness.

<u>January 13, 2021</u>: Senator Manchin urged the Department of Education to swiftly implement additional support he secured in the year-end package to better assist students experiencing homelessness in West Virginia.

<u>January 29, 2021</u>: Senators Manchin and Capito announced \$9,102,145 from HUD Continuum of Care (CoC) awards to 21 different organizations across West Virginia.

**February 9, 2021:** Senator Manchin introduced the bipartisan *Emergency Family Stabilization Act* to create a new emergency funding stream to provide flexible funding for community-based organizations working to meet the unique and challenging needs of children, youth, and families experiencing homelessness.

<u>February 26, 2021</u>: Senators Manchin and Capito announced over 51 awards totaling \$47,761,814 from HUD that aim to create and provide quality, affordable housing and address homelessness across West Virginia.

March 6, 2021: The Senate unanimously passed Senator Manchin's bipartisan amendment to include \$800 million in the *American Rescue Plan* to support students currently experiencing homelessness.

April 6, 2021: Senators Manchin and Capito announced three awards totaling \$3,302,454 from HUD that aim to create and provide quality, affordable housing and address homelessness across West Virginia.

**April 9, 2021:** Senator Manchin announced \$28,290,754 for affordable housing programs in West Virginia which received funding through the *American Rescue Plan*.

April 13, 2021: Senator Manchin led five bipartisan Senators in urging U.S. Department of Education Secretary Miguel Cardona to implement the \$800 million fund included in the *American Rescue Plan* to support children and youth experiencing homelessness and to help schools identify and assist students experiencing homelessness due to the COVID-19 pandemic.

<u>April 23, 2021</u>: Senator Manchin announced that West Virginia would receive over \$1.2 million in the first round of awards from the \$800 million he worked to secure in the *American Rescue Plan* to help schools identify and assist students currently experiencing homelessness.

<u>July 28, 2021</u>: Senator Manchin announced that the remaining funding from the *American Rescue Plan* dedicated to helping identify and assist students experiencing homelessness was awarded. West Virginia received over \$3.7 million from this second award.

<u>September 3, 2021</u>: Senator Manchin announced \$125,000 from the HUD Fair Housing Initiatives Program (FHIP) for the West Virginia Coalition To End Homelessness.

**September 8, 2021:** Senator Manchin announced \$77,313.60 from the *American Rescue Plan* for CommunityWorks in West Virginia, which supports individuals experiencing homelessness and individuals facing housing instability, such as eviction, default, foreclosure or loss of income.

<u>September 15, 2021</u>: Senator Manchin announced \$3,827,406 from the U.S. Department of Housing and Urban Development to organizations working to address and prevent youth homelessness in West Virginia.

<u>September 20, 2021</u>: Senator Manchin announced \$4,022,673 from the U.S. Department of Housing and Urban Development (HUD) for 14 West Virginia housing organizations and facilities across the state to provide affordable housing for low-income seniors.

<u>September 28, 2021</u>: Senator Manchin announced \$500,000 from the U.S. Department of Health and Human Services (HHS) Family and Youth Services Bureau for two West Virginia organizations to support West Virginia youth currently experiencing homelessness.

October 18, 2021: Senator Manchin secured West Virginia priorities in nine appropriations bills, including \$2 million for Barbour & Harrison Homeless Housing.

October 28, 2021: Senator Manchin introduced bipartisan, bicameral legislation to expand the Department of Labor (DOL) Homeless Veterans Reintegration Program (HVRP) to all 50 states and U.S. territories. The HVRP program offers job training services to Veterans experiencing or at risk of experiencing homelessness.

<u>November 4, 2021</u>: Senator Manchin led 14 Senators in introducing a bipartisan resolution recognizing November 2021 as National Homeless Children and Youth Awareness Month to bring attention to the children and youth experiencing homelessness across the country.

<u>December 22, 2021</u>: Senator Manchin announced \$623,703 from the U.S. Department of Housing and Urban Development (HUD) for housing assistance in West Virginia.

January 27, 2022: Senator Manchin announced \$2,134,042 from the U.S. Federal Emergency Management Agency (FEMA) to counties across West Virginia as part of the Emergency Food and Shelter Program. This funding will be used to provide food and housing to West Virginians experiencing food insecurity and homelessness.

February 9, 2022: Senator Manchin announced \$101,160 from the U.S. Department of Housing and Urban Development (HUD) to three West Virginia housing organizations to provide quality housing for all West Virginians. This funding will be used for counseling services, promoting financial literacy and other programs to address homelessness in West Virginia, especially children and youth homelessness.

March 11, 2022: Senator Manchin secured West Virginia priorities in the FY22 federal budget, including \$3.2 billion to address homelessness, as well as \$107 million to end youth homelessness and \$149 million for the Administration for Children & Families' Runaway & Homeless Youth Program.

March 16, 2022: Senator Manchin announced \$9,346,404 from the U.S. Department of Housing and Urban Development (HUD) Continuum of Care (CoC) Program for nineteen West Virginia organizations that help quickly rehouse individuals and families currently experiencing homelessness. The programs also support adults and youth fleeing domestic violence, dating violence, sexual assault and stalking.

May 2, 2022: Senator Manchin announced \$1,198,500 for the Randolph County Housing Authority (RCHA) to provide quality housing for all West Virginians in the surrounding communities.

May 16, 2022: Senator Manchin announced \$37,722,172 from the U.S. Department of Housing and Urban Development (HUD) for twenty West Virginia housing authorities to provide quality housing for all West Virginians.

<u>August 16, 2022</u>: Senator Manchin announced \$221,419 from the U.S. Department of Housing and Urban Development (HUD) for two West Virginia housing authorities to help provide quality housing for all West Virginians.

<u>September 28, 2022</u>: Senator Manchin announced \$7,981,516 from the U.S. Department of Health and Human Services (HHS) for seven programs that will assist young West Virginians experiencing homelessness, strengthen healthcare services and support medical research.

<u>September 28, 2022</u>: Senator Manchin announced \$697,260 from the U.S. Department of Housing and Urban Development (HUD) for 17 West Virginia housing authorities to help provide quality housing for all West Virginians.

November 17, 2022: Senator Manchin led 13 bipartisan Senators in introducing a bipartisan resolution to designate November 2022 as National Homeless Children and Youth Awareness Month to bring attention to the children and youth experiencing homelessness across the country.

<u>December 15, 2022</u>: Senator Manchin announced \$180,151 from HUD for two West Virginia housing authorities to help provide quality, affordable housing for all West Virginians. This funding will specifically support households that include non-elderly individuals with disabilities.

<u>December 20, 2022</u>: Senator Manchin announced \$2.1 million for 18 West Virginia rural development projects, including \$294K for the repair or rehabilitation of housing owned or occupied by low- and very-low-income rural citizens.

<u>January 6, 2023</u>: Senator Manchin announced \$516,228 from HUD for two West Virginia housing authorities to help provide quality, affordable housing for all West Virginians.

<u>January 11, 2023</u>: Senator Manchin secured more than \$2.4 billion in funding for top West Virginia priorities in 2022, including \$69.7 million in HUD funding to ensure every West Virginian has access to quality, safe, affordable housing, no matter where they live.

<u>February 3, 2023</u>: Senator Manchin announced \$1.2 million from HUD or the West Virginia Coalition to End Homelessness and Apple Tree Garden Apartments in Ranson to help provide quality, affordable housing for all West Virginians.

<u>February 17, 2023</u>: Senator Manchin announced \$17.6 million from HUD for 30 housing authorities across the state to help ensure quality, affordable housing for all West Virginians.

<u>February 28, 2023</u>: Senator Manchin announced \$409,000 from NeighborWorks America for the Homeownership Center in Elkins and CommunityWorks in Charleston. The funding will support developing and improving affordable housing, providing critical community-based services and creating good-paying, long-term jobs.

March 1, 2023: Senator Manchin announced \$34.5 million from HUD for the state of West Virginia and nine West Virginia communities to help provide quality, affordable housing for all West Virginians.

March 14, 2023: Senator Manchin announced \$293K from HUD for 16 West Virginia housing organizations to support connecting West Virginians living in multifamily housing who are elderly or living with disabilities with critical community-based services.

<u>March 28, 2023</u>: Senator Manchin announced \$9.7 million from HUD to support quality, affordable housing for all West Virginians.

May 3, 2023: Senator Manchin announced \$3.4 million from HUD to support safe, affordable housing for all West Virginians.

<u>June 26, 2023</u>: Senator Manchin announced \$81K from HUD to support safe, affordable housing for all West Virginians.

<u>August 9, 2023</u>: Senator Manchin announced \$657K from HUD for 13 West Virginia housing organizations and facilities across the state to provide affordable housing for low-income seniors.

<u>September 13, 2023</u>: Senator Manchin announced \$685,239 from HUD for six housing organizations across the state to provide safe, affordable housing for all West Virginians.

October 19, 2023: Senator Manchin announced \$582K from HUD for the Woodlands Development Group to construct and operate 14 rent-assisted units for low and very low-income seniors in the Rupert area.

November 1, 2023: Senator Manchin secured language in the FY 2024 T-HUD funding bill to address homelessness, including directing HUD to report on the feasibility of collecting eviction, foreclosure, and overall housing loss data; urging federal agencies to redouble their focus on youth homelessness; and directing federal homeless prevention grant programs to operate on two-year, rather than one-year, cycles to provide nonprofits with the time and certainty they need to serve our most vulnerable citizens.

**November 1, 2023**: Senator Manchin secured more than \$3.1 billion in the FY 2024 MilCon-VA funding bill to support the VA's homelessness prevention programs.
